The school uses existing safeguarding arrangements in exercising its Prevent duty. Referrals are made to relevant agencies where a Prevent concern is identified. Equip staff to identify children at risk of being drawn into terrorism and to challenge extremist ideas. Ensure that pupils have a "safe environment" in which to discuss "controversial issues".

Pupils develop "the knowledge, skills and understanding to prepare them to play a full and active part in society".

- Through PSHE/Citizenship, and other curriculum activities, pupils are able to explore political, religious and social issues.
- Pupils are taught about the diverse national, regional and ethnic identities in the UK and the need for mutual respect.
